## **Pleasantville City Council Meeting**

## June 15, 2021 at 5:30pm

Mayor Steve Marsh opened the public hearing on the FY 2021 budget amendment with council members Kody Jurgens, Kyle Patterson, and Jordan Van Ness present. Council member Clinton Wallace was present via zoom. City Clerk, Rachel Reed, explained the increased expenses were for the following: recreation is due to reimbursements for little league due to Covid-19, Jasper St. project completion and business type expenses for the new wastewater treatment plant digester. Increases transfers out of GO Bonds to road use tax to reimburse for engineering fees for the Jasper Street project. Also, increased transfers out of local option sales tax to debt service for the GO Bond payment. Motion by Patterson, seconded by Jurgens to close the public hearing. All voting in favor motion carried.

Council Member Jurgens gave thanks to the Pig Out Committee and all the volunteers.

City Administrator/Police Chief, Joe Mrstik explained the Pig Out celebration went well. The Betterment Committee will host a movie night tomorrow evening, they have 4 nights scheduled for movie night this summer. Mrstik informed the council that Officer Veatch is doing well and will be on his own by the end of June. Mrstik also informed the council that he has been working with Mr. Adkins on the development, he explained the RISE grant application will be on the agenda the next council meeting.

Librarian, Joellen Glick, informed the council that the library will be holding a re-dedication ceremony next Wed. at 7pm due to the city taking over the library.

Motion by Jurgens, seconded by Van Ness to approve the consent agenda as follows; approval of previous council meeting minutes, approval of May 2021 financial reports, approval of water consumption report for May 2021, approval of employee comp time, approval of Police Report, approval of Class C Beer & Class B Wine Permit renewal for Dollar General, approval of Tobacco/Nicotine/Vapor Permit for Casey's General Store, approval of Tobacco/Nicotine/Vapor Permit for Solar Drops Vapor, and approval of the following bills: All voting in favor, motion carried.

## New Business:

Nick Frederiksen with ISG Engineering discussed with the council the State St. water main project and project schedule. He explained the project is broke in to four sections. The first section is the 10in water main loop on Jones Street, down N State St and back down W Pleasant St. Section two would be to replace the existing 10in water main from W Pleasant St. to West Clark St. Section three proposes to replace the existing 10in along State Str. From Jones St. to Dallas St. The fourth section proposes a 10in water main for the school's fire protection line. The city is currently working on a survey to apply for a CDBG grant which is due October 2021. Final Plans and Specifications will be completed in November and the earliest the project will bid is February 2022. The council discussed working with the school on the cost for the fire protection line. Motion by Jurgens, seconded by Patterson to approve ISG's preliminary engineering report. All voting in favor motion carried.

Council Member Van Ness and Chief Mrstik left on a rescue call at this time.

Frederiksen explained to the council that their contract includes the preliminary engineering report, working with Simmering & Cory to make sure the project is funded properly, planning, topographic survey, final design, permitting to the DNR, bidding, construction administration, staking, resident observation and as built plans. Motion by Patterson, seconded by Jurgens to approve the design contract and agreement with ISG. All voting in favor motion carried.

Josh Jenkins with High Hopes Home Solutions LLC submitted an offer in the amount of \$5090 to purchase 105 E Dewitt St. Motion by Patterson, seconded by Jurgens to approve Resolution 21-14, authorizing the disposal of 105 E Dewitt St. to High Hopes Home Solutions LLC in the amount of \$5090. The property will be sold as is, conveyance shall be by Quit Claim Deed, sale shall be without abstract; however, buyer may obtain abstract at buyer's cost. Construction of a single-family residence shall commence no later than June 15, 2022 and be completed no later than June 15, 2023. All voting in favor motion carried.

Tami Farrell and Rachel Lopez have submitted letters of interest to fill the council vacancy. Tami and Rachel both gave the council a summary of themselves and what they do. The council asked each potential candidate a few questions before deciding. Motion by Jurgens, seconded by Patterson to appoint Rachel Lopez to fill the council vacancy until the next regular election. All voting in favor motion carried. The council encouraged both Tami and Rachel to run for council at the upcoming election.

Kelsey Waits at 303 E Monroe talked to the council about the property adjacent to her at 307 E Monroe. She informed the council that they are interested in purchasing that property from the city. The council discussed this lot, it is currently a non-conforming lot. The city has about \$5800 in demolition costs and has paid the back taxes. The council discussed possibly splitting the lot, because in the future if the city would acquire the opposite adjoining property it could still be combined and be a conforming lot. Kelsey explained she would discuss this with her fiancé and be in contact with the city.

Motion by Jurgens, seconded by Patterson to approve the FY 2021 budget amendment. All voting in favor motion carried.

Motion by Patterson, seconded by Jurgens to approve Resolution 21-17, approving transfers from GO Bonds to Road Use Tax fund for engineering fees. All voting in favor motion carried.

Motion by Patterson, seconded by Jurgens to approve the following Local Option Sales Tax Grant applications and amounts; Pleasantville Senior Center \$4,000, Marion County Special Olympics \$600, Pleasantville Garden Club \$500, Pleasantville After Prom Task Force \$500, Friends of the Webb Shadle Library \$4300, Pleasantville Youth Initiative \$1000, American Legion Post 108 \$650 and HIRTA Public Transit \$3388. All voting in favor motion carried.

Motion by Wallace, seconded by Patterson to approve LL Pelling quote for seal coat in the amount of \$22,274. All voting in favor motion carried.

Mrstik and Van Ness arrived back at the meeting at this time.

Motion by Jurgens, seconded by Patterson to approve Faller, Kincheloe & CO, PLC to complete the FY 2021 annual financial exam in the amount of \$4120. All voting in favor motion carried.

Motion by Patterson, seconded by Jurgens to table Resolution 21-18. All voting in favor motion carried. Motion by Patterson, seconded by Jurgens to approve Ordinance No. 2108, third reading, adding a new chapter entitled UTVs. All voting in favor motion carried.

Motion by Jurgens, seconded by Patterson to pass the first reading for Ordinance No. 2109, amending Chapter 69 pertaining to no parking zones. All voting in favor motion carried.

Old Business:

Mrstik explained the survey for the pit bull ordinance is done and he will get with Flaws to assist with getting the results.

The council discussed the library levy, a petition will have to be completed to get the levy on the ballot. The council would like the library board to obtain the signatures needed for the petition.
