New Business:

Breazeale informed the council that Jeff Miller contacted him about a water leak at 108 S Sunset Dr. The water leak was a line under the house, and it did not go down the sanitary sewer. Motion by Jurgens, seconded by Patterson to approve a sewer adjustment of \$448.90 for 108 S Sunset Dr. All voting in favor motion carried.

Breazeale informed the council that 505 S Business Hwy 5 had a comparable situation, Jeff contacted him and there was a water line that had broken under that house and did not go down the city's sanitary sewer. Motion by Patterson, seconded by Jurgens to approve a sewer adjustment of \$649.15 for 505 S Business Hwy 5. All voting in favor motion carried.

Motion by Patterson, seconded by Jurgens to set a public hearing to accept public comments on plans, specifications, and cost estimate for the 2021 Watermain Improvements Project for May 3, 2022, at 4:00pm. All voting in favor motion passes.

Motion by Patterson, seconded by Jurgens to approve \$15,000 for funding for fireworks. All voting in favor motion carried.

Motion by Jurgens, seconded by Patterson to approve street closure on State Street from Monroe to Jones on May 10th from 5:30pm-8:30pm for the school Spring Concert, rain date is May 17th. All voting in favor motion carried.

Motion by Patterson, seconded by Jurgens to approve May as free pet license month. All voting in favor motion carried.

Motion by Patterson, seconded by Jurgens to approve waiving the vendor fee for food trucks for the Pig Out event and for the Pleasantville Youth Initiative event May 30th. All voting in favor motion carried.

Motion by Jurgens, seconded by Patterson to approve concrete for the Jasper St. Park sidewalks and little league fields, to come from local option sales tax fund and not to exceed \$40,000. All voting in favor motion carried.

Motion by Jurgens, seconded by Patterson to approve the agreement between the Iowa DOT and the City for the RISE project. All voting in favor motion carried.

Motion by Jurgens, seconded by Patterson to approve agreement with Snyder & Associates to perform the design, prepare the documents and bid the project for the RISE project. All voting in favor motion carried.

Motion by Patterson, seconded by Jurgens to approve pay app #8 for C.L. Carroll for the WWTP Digester in the amount of \$10,450. All voting in favor motion carried.

Motion by Patterson, seconded by Jurgens to approve the purchase of a tiller for the skid loader from Bobcat for \$5072.40 to come from the equipment replacement fund. All voting in favor motion carried.

Motion by Jurgens, seconded by Patterson to set a public hearing for the FY22 budget amendment for May 17, 2022, at 5:30pm. All voting in favor motion carried.

Motion by Jurgens, seconded by Patterson to adjourn. All voting in favor motion carried.
